





## **Pre-paid Funeral Planning**

The growth in funeral costs significantly outstrips inflation measured by the Retail Prices Index, which increased by 3.5% over the same period.

The average cost of a funeral in the UK is £4,798 for a burial, with average cremation funeral costs at £3,744 according to Sun Life's 2018 Cost of Dying Report. Those costs factor in the person's burial or cremation, funeral director services, and doctors' and celebrant fees.

Pre-paying your funeral can save you money and give you the freedom to plan things exactly how you would want them whilst at the same time sparing your loved ones the potential distress and not considerable expense of arranging one. A Pre-paid Funeral Plan gives you the peace of mind of knowing that the arrangements you want will be met whilst at the same time helping you to put your affairs in order and protecting those closest to you from the stress and expense of arranging your funeral.
